FROM THE AUGUST 2020 NEWSLETTER

At the close of voting (5pm 31 July) our returning Officer (Colin Magilton) had received 49 Voting Forms. He reports:

What a record breaking year 2020 has been. For the first time in the history of our cooperative we have been forced to conduct our AGM via remote means, including voting on the procedural motions we need to conduct each year. We have all learnt to do things differently this year and we thank the members for engaging in this form of AGM. We received 49 voting papers. Some members were so keen that they submitted their votes by both email and post, one of these quoting the old axiom "vote early and vote often". We only counted each member's vote once. The table below summarises the voting.

In case you've forgotten the Motions were:

Motion 1. That the Minutes of the 2019 AGM and General Meetings be accepted. CARRIED

Motion 2. That the 2020 Chair's Report be Accepted. CARRIED

Motion 3. That the audited Financial Report be accepted. CARRIED

Motion 4. That Sinclair Wilson be re-appointed as Auditors for the coming financial year. CARRIED **Motion 5**. That the Annual Levy be increased to

Motion 6. That the Annual Levy remain at \$15 per year or \$60 for 5 years. LOST

\$20 per year or \$80 for 5 years. CARRIED

Several people abstained from voting to accept the 2019 AGM minutes on the grounds that they were not present. There were a couple of minor voting anomalies, such as voting 'Yes' to both retain and increase the levy. There were several people who genuinely voted against some of the motions, however the motions were overwhelmingly carried.
