RULES RELATING TO USE OF THE KURRI KURRI PROPERTY AT NARINGAL, VICTORIA

ACCESS

1. Available to members, and immediate family of members, of Kurri Kurri Co-operative Society Ltd for holiday, educational and recreational purposes.
2. Available to friends of members, provided they are accompanied by that member during their stay

NOTE

- a. The term “member” means a shareholding member of Kurri Kurri Co-operative Society Ltd.
 - b. The term “immediate member of family” means the spouse of a member and their children provided they are aged sixteen years or under.
 - c. The term “friends of members’ means relatives of members other than immediate family and any other persons accompanying a member.
3. Subject to approval by the Board of Directors on each occasion, use of the property may be afforded to others for such periods and on such conditions as are determined by the Board. Such use shall be within the statement of purposes of the Co-operative.
 4. Access to the block is not permitted on days when the Victorian Fire Danger rating is “Severe” or higher and on days of total fire ban.
 5. Visitors may stay overnight using their own tent or vehicle in the camping area(s) set aside for this purpose by the Directors.
 6. During periods when available accommodation may be fully used e.g. in school holidays or Christmas holidays, bookings will be necessary with the Secretary or other such person as nominated by the Directors, who will either conduct a ballot or a roster system at their absolute discretion.

ACTIVITIES

7. FIREARMS are not permitted on the property without prior authorisation from the Board.
8. Unless authorised by the Directors, animal and bird traps, other than types used for catching vermin, are not to be used on the property.
9. HORSES are not permitted on the property.
10. CATS are banned from the property at all times. Members’ DOGS will be tolerated only under strict supervision and must be kept on a leash at all times.
11. FIRE is the greatest danger to this and surrounding property. Fires must not be lit except in the fireplaces provided.
12. NO FIRES are permitted during days of total fire ban and other times as specified by the Board or by Law.
13. TANK WATER is non-potable and must be boiled before use.
14. FIREWOOD is only to be obtained from dead and fallen timber.
15. FELLING OF TIMBER is not permitted except as part of organised maintenance activities.

16. WILDFLOWERS. Picking of wildflowers, especially orchids, is not permitted; however, the collection of cuttings or seed for propagation purposes will be allowed if approved by Directors.

RESPONSIBILITIES

17. SIGNING IN. All visitors to the block must sign in to the Visitors Book located under the shed awning.
18. GARBAGE is the responsibility of each member and must be removed from the property.
19. SECURITY. Prior to leaving the property, close and lock appropriate doors and gates and ensure all lockable assets (ladders, mowers, shed) are secured.
20. VEHICLES are allowed only on access track unless authorised by the Directors. Parking is permitted in designated areas only.
21. CLEANLINESS is the responsibility of each member. Please leave the property the way you would like to find it.
